Minutes of the last meeting were read and approved, seconded by Linda Gallant.



We are not aware of any other place having one. We cannot afford to keep it. The **motion was carried** with one dissenting vote.

Marion Barrieau has resigned as chairperson of the Membership committee due to illness. President Rosemarie explained the duties of the membership chairperson.

The question arose as to whether we should bring hard copies of the minutes to the general meeting. The membership voted in favour of keeping the status quo. Therefore, the minutes will continue to be read.

There were 3 items of correspondence. Two were cards of thanks for donations to the Scholarship fund, and one contained a cheque to the scholarship fund.

**Treasurer's report -** Dave Barker gave a detailed report of our finances, copies of which were given to members. This is a summary of our financial standing.



**NBSRT -** The report was presented by Pat Clancy. The annual meeting was held on April 27, 2010 in Fredericton. Highlights included:

The name of Claudia McNeil was resubmitted to sit on the Workplace Appeal Tribunal Board as a representative of NBSRT NBSRT is in strong financial condition

There was discussion regarding the formation of an Atlantic Provinces Association for retired teachers.

Group Insurance: no change to ADD component. The health insurance increase is most likely due to costs involved with travel insurance; no increase to Dental and Prescription Drug component of the plan; Plan is increasing coverage (to \$600.00) for services – physio, massage therapy, etc.; additional homeopathic drugs covered. (smoking cessation, potassium supplements, quinine)

As for travel insurance, if there is a pre-existing condition, contact Johnson Insurance and obtain a letter from your doctor stating that it is okay for you to leave the country.

Mike Ketchum replaces Larry Jamieson as director of Teacher Welfare. Pension plan is outperforming long-term forecast.

## **New Business**

- 2. A Scholarship is given to one local high school and rotates each year. At our last Board meeting, a motion was passed to offer bursaries to all local graduating high schools.

It was moved by Wendy Matthews and seconded by Dale MacRae "That a bursary of \$200.00 be given to each of the graduating High Schools. This bursary is to be reviewed each year." Discussion: Because we need to give back to the community in order to remain a charitable organization, and we need to give money to satisfy Canada Revenue Agency, it makes sense to donate to the schools. This money will be taken from General funds, and not from the Scholarship fund. It must be reviewed annually and will be awarded as we are able to. **Motion carried**.

3. There was also a motion passed at our February 8 Board meeting to make a donation to the Haiti fund. The "shelter box" was explained. It was moved by Dorothy Creighton and seconded by Maria Brown that "a donation of \$1000.00 be given to the Haiti fund through the Salvation Army. This is a one time only donation." **Motion carried**.

**Nominations** – Bill Rigley chaired the nomination committee. There was but one nomination to be filled. Wendy Matthews was elected chairperson of the membership committee by acclamation.

The meeting adjourned under a motion by Judy Fox Roy, seconded by Shirley MacDiarmid.
